What is ESOS?

The Energy Savings Opportunity Scheme (ESOS) is the UK Government’s mandatory energy auditing scheme, which requires all UK “large undertakings” to carry out an energy audit every four years.

In the UK, an organisation is considered a large undertaking if:

1. It has 250 or more employees, or
2. It has fewer than 250 employees, but its annual turnover and its annual balance sheet exceed £42.5bn and £36.5bn, respectively.

In addition, if an organisation is part of a group of organisations that contains at least one large undertaking, it lies within the scope ESOS.

How to Comply with ESOS

Each qualifying ESOS participant is required to estimate its total energy consumption (including energy used in buildings, industrial processes and transport), identify cost-effective energy saving opportunities and submit a formal notification to the Environment Agency confirming that it has met the requirements of ESOS in each compliance period.

ESOS runs in four-year compliance phases. Within each four-year period, a qualification date and a compliance date have been set. Participants must assess whether they are considered large organisations (and therefore, whether they fall within ESOS) on the Qualification Date of each phase. If they qualify as a large organisation, they must meet ESOS requirements before or on the Compliance Date of each phase. ESOS began in 2014 with the first Phase ending on 5th December 2015. The second Phase is already underway and ends on 5th December 2019. The qualification date for Phase 2 is 31st December 2018.

ESOS participants are required to:

- determine their total energy consumption over the Reference Period (a 12-month period spanning the Qualification Date of each phase);
- identify their areas of significant energy consumption to account for at least 90% of all energy consumption or cost;
- take into consideration which ESOS compliance routes are available for covering their areas of significant energy consumption and choose the most appropriate routes to compliance for them.;
- assign a lead auditor to conduct and/or supervise the necessary energy audits and/or approve the ESOS assessment;
- ensure that a director/senior manager has signed off the main energy saving conclusions and recommendations coming from the ESOS assessment;
- submit a formal notification to the Environment Agency confirming their compliance with ESOS.

As well as energy audits, participants can also use other forms of audit such as Display Energy Certificates (DECs) or certification of part or all of their organisation to the Energy Management Standard ISO50001.
